### 1709. Footpath Report

It was reported that:

FE6 Cllr Henley had spoken to the land owner about the tree causing an obstruction.

FE7 The steps down to the A5 had been reported to Highways England and a work order issued

### 1710. Community Defibrillators.

### 1711. Historic Memorials

The Radar Memorial maintenance was still being undertaken by Romer Adams from Bugbrooke with colleagues. They would continue to work on the site in the spring and would re-do the Sadolin on the interpretation board. Council may need to budget for a new fence in the next financial year as the fence is leaning badly and will need to be replaced in total or in part.

### 1715. Broadband

Gigaclear had made some changes to their work programmes to assist the businesses at the Old Dairy Farm, and it was expected that connections in Church Stowe would begin in mid January

### 1717. CPRE

### 1718. Complaints.

Members discussed a complaint that the Clerk had received regarding the visual amenity of the green approach to Church Stowe from the A5, which had been referenced in the Village Design Statement, the increased presence of rats and the dazzling green lights that had been installed. Councillors instructed the Clerk to:

- i. Contact the police regarding the hazard to drivers created by the 'laser style lights', enclosing a copy of the adopted Anti Social Behaviour Policy.
- ii. Contact Daventry District Council regarding the increased incidence of rats possibly attracted by bird feeders and the fly tipping of garden waste.
- iii. Contact the NCC Highways Regulation team regarding the introduction of non-standard items on the highways verge (photographs to be supplied).
- iv. Write to the neighbouring resident informing him of the Council's actions.

### 1719. A5 Flooding and Update re roadworks

The Clerk had previously advised that Highways England had responded with regard to the footpath steps down to the A5, but no response had been received regarding the potholes that Cllr Henley had reported.

The Clerk would report them again to try and elicit a response.
