1940. Apologies for absence

WND/2021/0668 - Old Dairy Farm, Main Street, Upper Stowe, -Building for agricultural use with vehicular access and hardstanding (retrospective)

Having listened to the views of residents, Councillors agreed to submit a policy-based response which supported the agricultural use, but only for the applicant's own purposes, if the building was returned to one which was compliant with the relevant permitted development regulations.

Councillors noted the overwhelming concern from residents of Upper Stowe regarding the end use of the building and would ask for monitoring of the application(s) and any consent.
